Privacy Policy

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Push may collect personally identifiable information, such as your name, address, email, phone, survey questions, clicks, locations and other data.

Push may also collect anonymous demographic information, which is not unique to you, such as your likes/dislikes, general information, age, gender, race, religion, and more.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. -Data collection
